ELIGIBILITY

The exhibit is open to all photographers. Each entrant may submit a maximum of three entries. The entries may be color or black and white, 35mm or digital.

All work must have been taken in the Wilson Creek watershed east of the Blue Ridge Parkway between October 1, 2009 and September 30, 2010.

SPECIFICATIONS

This is a juried exhibition. Photographs should have value in showing the natural beauty of the area and enriching ways it can be enjoyed, including appreciation of the area's history. The selection of photographs to be exhibited will be at the discretion of the judge. Photographs not included by the judge for exhibit may be picked up at the opening reception. All work submitted must be on WHITE matte only. A frame will be provided for display of pictures whose sizes are 11"x14" and 12"x16" with the matte. Other size photos should be framed when submitted. Identification labels must be attached to the back upper right corner. **Sale price must be listed. If not for sale, an insurance value must be given. No work may be removed before the end of the exhibit.** FRIENDS OF WILSON CREEK reserve the right to photograph and reproduce accepted works for publicity.
